

REQUEST FOR PROPOSAL FOR THE ARCHITECTURAL DESIGN AND ANCILLARY CONSULTING SERVICES FOR THE DEVELOPMENT OF THE PROPOSED AFRICA RE CORPORATE HEAD QUARTERS BUILDING AT THE CENTRAL BUSINESS DISTRICT, ABUJA, NIGERIA

1. BRIEF

The African Reinsurance Corporation (Africa Re) is an international organization with Headquarters in Lagos, Nigeria. Africa Re has six regional offices in Abidjan (Côte d'Ivoire), Cairo (Egypt), Casablanca (Morocco), Lagos (Nigeria), Nairobi (Kenya), and Port Louis (Mauritius). In addition, Africa Re wholly-owns a Subsidiary in South Africa (Africa Re South Africa Limited) and a Retakaful company in Egypt (Africa Retakaful Company).

The Corporation is owned by 41 member states of the African Union (AU), the African Development Bank (AfDB), 111 African insurance and reinsurance companies in Africa and 3 leading global insurance and reinsurance groups.

The current headquarters of Africa Re is located in Lagos at 1679 Karimu Kotun Street, Victoria Island, Lagos, Nigeria.

Africa Re would like to relocate its head office to Abuja, Nigeria, the Federal Capital City of the Federal Republic of Nigeria, by developing a new building for its headquarters.

For that, it has already acquired a plot of land located at Plot No. 1572, Central Area, Cadastral Zone A00, in the Central Business District (CBD) of Abuja, adjoining the Federal Ministry of Finance.

2. INTRODUCTION

Africa Re is in the process of developing its Corporate Headquarters Building in the CBD of Abuja, Nigeria.

The project being contemplated will be

- Modern and outstanding in design to reflect the Corporate Image of Africa Re
- Different from the surrounding buildings
- High rise office building
- Adjustable open floors design
- With first class facilities
- Using sustainable material
- Protecting the environment
- Smart building
- Energy efficient
- Easily accessible by physically challenged persons
- Meeting high security standards
- Meeting standards that will ensure maximum return on investment.

3. SCOPE OF WORK

The role of the participating architectural firm is to present design concepts and ancillary consulting services for a high rise office building of between seven (7) to ten (10) floors and guided by the brief below:

 - Space to be used / developed as per land administration authorities
 - Expected rental income
 - Estimated payback period
 - Average running cost

5. CONDITIONS FOR ELIGIBILITY

Invited architectural consulting firms are required to have in their organizations, qualified Project Managers, Services Consultants (MEP) and Structural Engineers.

The firms are also to submit pre-qualification documents detailing their company's capabilities, evidence of registration with relevant professional bodies, cognate experience of practicing firm's partners and proven experience in modern office building design. Any claim on qualification, capabilities and experience must be evidenced and Africa Re given the right to contact the third parties.



In addition to the eligibility conditions above, the submissions must be accompanied with the following:

- Evidence of Company Registration with the relevant authorities in the home country and in Nigeria where applicable;
- Evidence of License to operate in the home country and in Nigeria in case foreign firms;
- Company's audited accounts for the last three years (2015-2017);
- Evidence of financial capability;
- Evidence of having successfully carried out similar design works within the last five years;
- Evidence of having provided consultancy and structural engineering services on similar works within the last five (5) years;
- Comprehensive company profile and organizational structure;
- Resumes and evidence of employment relationships / contracts of key Architects, Engineers & Project Managers to be deployed permanently and/or partially to the envisaged project;
- Evidence of availability of requisite and appropriate staff/skill for job;
- Indication of the financial institution (bank or insurance company) which is usually used for performance or advance payment guarantees
- In case of an international firm, evidence of local partnership.

6. SELECTION OF WINNING DESIGN CONCEPT


